THIS TERMINATION OF LEASEBACK AGREEMENT (the "Termination of Leaseback Agreement") dated as of August 26, 2024 by and between ONEIDA COUNTY INDUSTRIAL DEVELOPMENT AGENCY, a public benefit corporation duly existing under the laws of the State of New York with offices at 584 Phoenix Drive, Rome, New York 13441-4105 (the "Agency") and THE INDIUM CORPORATION OF AMERICA, a New York corporation with an address of 34 Robinson Road, Clinton, New York 13323 (the "Company").

WITNESSETH:
